# Drop-Off & Pick-Up

## Directions

The Jimmy Stewart Airport is located at 398 Airport Road in Indiana Pennsylvania (15701). The main terminal can be accessed via the double doors in the center of the building under the portico adjacent to the parking lot. Once inside, please look for Aviation Experience Check-In table.

## Drop-Off

Aviators will check in daily in the main terminal building located at the Jimmy Stewart Airport. Once checked in, your aviator will join their flight group for their morning briefing before departing the terminal building.

---

## Pick-Up

Aviators can be picked up by parent(s) or guardian(s) within the main terminal at the same location as the drop-off. Please ensure to have a valid picture ID each day. Your child will only be released to those persons identified as a parent / guardian. Any changes to pick-up must be submitted in writing to the staff.

# Health and Safety

## Health and Safety



Youth in Aviation is committed to offering safe, high-quality, and educational programming. The health and safety of all camp participants, staff, and their families is paramount. Staff certified in First Aid and CPR will be present throughout the duration of the camp.

If your child has a medical condition or allergy, it should be noted on your child's emergency information form. If you have any further concerns, please feel free to speak with the camp director or a member of our team.

## Medication



When possible, please arrange medication administration at a time other than camp hours so that medicine can be taken at home. In the event a child must have medication during camp hours, please communicate the need to a member of our team during check-in. This includes any OTC medications. Staff will be unable to administer medication that is not provided by the parents.

## Illness



If your child becomes ill or has a fever, please do not bring them to camp. You can call or text the contact number to let us know they will not be attending this day. If a child becomes ill during the program, a parent will be notified and asked to pick-up the child. If a parent is unavailable, an emergency contact will be called. A parent or designated person must arrive within 45 minutes. Your child must be fever free (lower than 100.4°) without medication for 24 hours before returning to the program. This is for the protection of all children and staff in the program.

# Health and Safety

## Camp Attire

Aviators should wear clothing that is comfortable. As many of our activities will be held outdoors, please be sure to send your children with appropriate attire that aligns with weather conditions.

Sunglasses, hats, and/or visors are encouraged.

As we will be navigating many parts of the airport and surrounding grounds, gym shoes and socks should be worn at all times (no sandals, crocks, clogs, etc.). No open-toed shoes.

## Sunscreen

Aviators should have sunscreen applied before arriving each day. Furthermore, please bring extra sunscreen for re-application. Aviators should know how to apply sunscreen on themselves as staff are not permitted to do so.

## Hydration

As many activities are outside and summer days can get hot, Aviators will be provided a reusable water bottle. They should bring them each day. Staff will ensure participants have the opportunity to refill their water throughout the day. Please do not bring soda or other sugary drinks.

## Introduction Flights



Introduction Flights are designed to provide participants\* the opportunity to experience flight in a hands on environment. The flight is 30-minutes in length and will be tailored to the age and experience of each aviator. The flights will be conducted by either a Certified Flight Instructor or Commercially rated pilot.

Introduction Flights are weather dependent and can be scheduled at the check-in / drop-off table daily. The flight may be scheduled anytime between June and December 2023.

\*Weight & balance restrictions will apply.
